

Cash Back Offer - Conditions of Use For applications for the period 6 March 2023 to 31 July 2023

CASH BACK OFFER CONDITIONS OF USE

When reading this, any reference to

- We, Us, and Our is a reference to Regional Australia Bank Ltd; and
- You and Your is a reference to the applicant, borrower or member of Regional Australia Bank.

What is the Cash Back Offer

The Cash Back Offer consists of *up to* \$4,000 cash back to be paid to you and an additional amount of \$500.00 to be paid to a Regional Australia Bank Community Partnership Recipient of your choosing for eligible loans funded within the period of the promotion (**Cash Back Offer**).

How much is the Cash Back Offer?

Borrowers will be eligible for the following amounts (if all other eligibility requirements are met):-

- 1. The amount of \$3,000.00 Cash Back for loans with a refinanced loan amount of \$250,000.00 to \$499,999.99 or
- 2. The amount of \$4,000.00 Cash back for loans with a refinanced amount of \$500,000.00 or greater.

How long is the Cash Back Offer for?

The Cash Back Offer is for the re-finance of eligible home loan applications received and approved from 6 March 2023 until 31 July 2023 and settled before 30 September 2023 (**Period of Promotion**).

Who is eligible for the Cash Back Offer?

To be eligible for the Cash Back Offer, you must:-

- 1. Successfully refinance your residentially secured home loan from another financial institution with Regional Australia Bank before the expiry of the Period of Promotion; and
- 2. Have a minimum borrowing amount of \$250,000.00; and
- 3. Have a loan to value ratio (LVR) of less than, or equal to, 90%; and
- 4. Have not repaid and closed the loan facility prior to the receipt of the Cash Back Offer.

The Cash Back Offer is limited to one payment, irrespective of the number of applicants or applications. No further loans in the name of either applicant (whether jointly or individually) will be eligible for the Cash Back Offer.

Loan applications, and the Cash Back Offer, are subject to our usual credit assessment and approval process. Borrowers who receive the Cash Back Offer are not eligible for any other promotional payments offered by us.

This offer is not available for refinances into our Basic Variable Introductory Offer, construction loans, commercial facilities or bridging finance.

How will the Cash Back offer be paid?

Cash payment

The cash payment will be paid to your eligible Regional Australia Bank account. If you hold more than one nominated account, we will determine which account will receive the payment.

An eligible Regional Australia Bank Account must:-

- 1. Be in the name of the Borrower(s); and
- 2. Be a deposit account (not a loan product account or term deposit account).

The \$500.00 payment will be made to your nominated Regional Australia Bank Community Partnership Recipient (**Recipient**).

You will be asked to nominate the Recipient at the time of your application.

When will the Cash Back Offer be paid?

The Cash Back Offer will be paid within sixty (60) days of the loan being funded.
