When making your decision you should consider the following important information:

- (a) Attendance at the Annual General Meeting (AGM), and other Meetings of members, of the Regional Australia Bank enables members:
 - (i) to participate in the governance of Regional Australia Bank;
 - (ii) to ask questions about, and comment on, the management of Regional Australia Bank, its financial standing and performance;
 - (iii) to ask the auditor of Regional Australia Bank questions about the conduct of the audit of Regional Australia Bank and the preparation and content of the auditor's report; and
 - (iv) to vote on any proposal to amend the constitution of Regional Australia Bank or on any other matter in relation to the management of Regional Australia Bank;
- (b) Notice of Meetings informs members about matters in relation to which they may wish to attend a Meeting;
- (c) A member of Regional Australia Bank who is entitled to attend, and cast a vote at, a Meeting may appoint a proxy to attend and vote for the member at the Meeting;
- (d) If the member does not elect to receive Notice, Regional Australia Bank is not required to give Notice of its Meetings to the member; and
- (e) Despite a member of Regional Australia Bank electing not to receive Notice of its Meetings or not making an election, the member may at any time request Regional Australia Bank to give them personal Notice of the Meetings.
